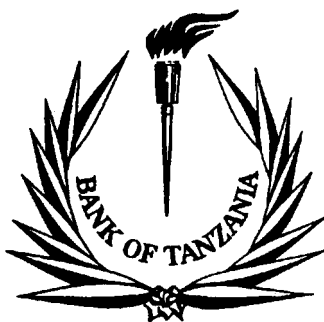

Supply, Installation, Testing and Commissioning of Vehicles Access Control Systems at Arusha and Mbeya Branches

1. The Bank of Tanzania has set aside funds for its operations during the financial year 2016/2017. It is intended that part of the proceeds of the funds will be used to cover eligible payment under the contract for **Supply, Installation, Testing and Commissioning of Vehicles Access Control Systems at Arusha and Mbeya Branches**.
2. Tendering will be conducted through National Competitive Bidding procedures specified in the Public Procurement Regulations, 2013 – Government Notice No. 446 and is open to all Tenderers as defined in the Regulations.
3. The Bank of Tanzania now invites sealed tenders from eligible Suppliers for **Supply, Installation, Testing and Commissioning of Vehicles Access Control Systems at Arusha and Mbeya Branches** as follows;

I	Supply of Traffic Booms and Spike Barrier Systems at Arusha and Mbeya Branches
II	Supply, Installation, Testing and Commissioning of High Security Road Blockers at Arusha and Mbeya Branches

4. Interested eligible bidders may bid for any of the lots or all lots but should quote for all items in the respective lot and price.

A complete set of Tendering Document(s) in English and additional sets may be purchased by interested Tenderers on the submission of a written application to the address given under paragraph 5 above and upon payment of a non-refundable fee of **TZS 100,000.00**. Payment should either be by Electronic Payment transfer (Account Name: Tender Application Fee, **Account Number: 9944712601**) or Banker's Cheque, payable to Bank of Tanzania.
7. All Tenders must be accompanied by a Bid Securing Declaration in the format provided in the Bidding Documents.
8. All tenders in one original plus two copies, properly filled in, and enclosed in plain envelopes marked **"Tender for Supply, Installation, Testing and Commissioning of Vehicles Access Control Systems at Arusha and Mbeya Branches"** must be delivered to the address given under paragraph 5 above at or before **11:00hours, 22nd December, 2016**. Bids will be opened promptly thereafter at the **Bank of Tanzania, Prospective Currency Museum Hall, Ground Floor, South Tower at 2 Mirambo Street, 11884 Dar es Salaam**.
9. Late Tenders, Portion of Tenders, Electronic Tenders, Tenders not received, Tenders not opened and not read out in public at the tender opening ceremony shall not be accepted for evaluation irrespective of the circumstance.
