The Bank of Tanzania has set aside funds for the operation of its Mwanza Branch during the financial year 2017/2018 and it is intended that part of the proceeds of the funds will be used to cover eligible payments under the contract for the **Proposed Rehabilitation of BOT House at Plot No.D44, Maendeleo Street, Isamilo Mwanza.**
2. The Bank of Tanzania Mwanza Branch now invites sealed Tenders from eligible contractors registered as Building Contractors under Class Six (VI) or above by the Contractors Registration Board (CRB) for carrying out the aforementioned works.
3. Tendering will be conducted through the National Competitive Tendering procedures specified in the Public Procurement Regulations, 2013 – Government Notice No.446, its amendments, 2016 and is open to all Tenderers as defined in the Regulations unless otherwise stated in the Tender Data Sheet.
4. Interested eligible Tenderers may obtain further information and inspect the Tendering Documents at the office of the **Secretary, Branch Delegated Tender Board, Bank of Tanzania-Mwanza Branch, P. O. Box 1362, Mwanza, Plot No. 1 & 2, Block K, Nyerere Road, 2nd Floor, Room No. 85,**

starting from **8.30 to 12.30 hours local time** and **14.30 to 16.30 hours' local time** on Mondays to Fridays inclusive except on public holidays.

5. A complete set of Bidding Document(s) in English and additional sets may be purchased by interested Bidders on the submission of a written application to the address given under paragraph 4 above and upon payment of a non-refundable fee of **TZS 100,000.00**. Payment should either be by cash, banker's draft, banker's cheque or electronic payment transfer payable to the **Branch Director, Bank of Tanzania, Mwanza Branch**, Account Name: **Intermediary Account Mwanza**, Account Number: **9924DAMZM**.
6. All tenders must be accompanied by a Bid Securing Declaration in the format provided in the Tendering Documents.
7. All Tenders in one original plus one copy properly filled in, and enclosed in plain envelopes clearly marked "**Tender for the Proposed Rehabilitation of BOT House at Plot No. D44, Maendeleo Street, Isamilo Mwanza**" must be delivered to the address under paragraph five (5) above at or before 10.00 local hours on **Monday, 18th September, 2017**. Tenders will be opened promptly thereafter in public and in the presence of Tenderers' representatives who choose to attend in the opening ceremony to be held at the BOT Mwanza Branch Board Room, Room No.31, 1st Floor, Left wing.
8. Late tenders, portion of tenders, electronic tenders, tenders not received, tenders not opened and not read out in public at the tender opening ceremony shall not be accepted for evaluation irrespective of the circumstances.
