1. The Bank of Tanzania has set aside funds for its operations during the financial year 2017/2018. It is intended that part of the proceeds of the funds will be used to cover eligible payment under the contract for Supply of Fire Detection and Alarm Systems at Arusha and Mbeya Branches.
2. Bidding will be conducted through National Competitive Tendering procedures specified in the Public Procurement (Goods, Works, Non-Consultant Service and Disposal of Public Assets by Tender) Regulations, 2013 – Government Notice No. 446.
3. The Bank of Tanzania now invites sealed bids from eligible companies for the Supply of Fire Detection and Alarm Systems at Arusha and Mbeya Branches as described in the schedule of requirements.

A complete set of Bidding Document(s) in English and additional sets may be purchased by interested bidders on submission of a written application to the address given under paragraph 4 above and upon payment of a non-refundable fee of TZS 100,000.00. Payment should either be by Electronic Payment Transfer (Account Name: Tender Application Fee, Account Number: 9944712601 or Banker's Cheque payable to Bank of Tanzania)
6. All bids must be accompanied by a Bid Securing Declaration in the format provided in the Bidding documents.

All bids in one original plus two copies, properly filled in, and enclosed in plain sealed envelopes marked **"Tender for Supply of Fire Detection and Alarm Systems at Arusha and Mbeya Branches"** must be delivered to the **Secretary, BOT Tender Board, Head Office, 2nd Floor South Tower, at 2 Mirambo Street, Post code 11884 Dar es Salaam, Tanzania** on or before **11:00hours, Wednesday 4th October, 2017**. Bids will be opened promptly thereafter in the presence of bidders' representative who choose to attend the tender opening ceremony at **Bank of Tanzania, Prospective Currency Museum Hall, Ground Floor, South Tower at 2 Mirambo Street, Post code 11884 Dar es salaam**.
8. Late Bids, Portion of Bids, Electronic Bids, Bids not received, Bids not opened and not read out in public at the bid opening ceremony shall not be accepted for evaluation irrespective of the circumstances.
