<b>9. Form of issuance</b>	Book entry system.															
<b>10. Redemption date</b>	Redemption dates 35 – Day 2 <sup>nd</sup> February 2017 91 – Day 30 <sup>th</sup> March 2017 182 – Day 29 <sup>th</sup> June 2017 364 – Day 28 <sup>th</sup> December 2017
